What is the ACP Observatory on Migration?

The Observatory is a institution designed to produce data on South-South ACP migration flows for civil society and policy-makers and enhance research capacities in ACP countries through networking and cooperation among organizations.

Objective:

The Observatory will create a network of research centres and private researchers to provide policy-makers, the civil society and the public at large with reliable and harmonized data on ACP migration. It will contribute to reduce the lack of reliable data on South-South migration and enhance cooperation between researchers from partners Universities and institutions.

The Observatory will be officially launched in October 2010. While currently based in Brussels (Belgium), the Observatory will move to one of the 79 ACP countries.



ACP Observatory Key Activities:

- Audit of existing data and research and identification of existing data gaps and research needs for gathering of new or complementary information and statistics;
- Liaise with existing migration research experts and networks to strengthen their capacity, and to establish new migration research networks of observatories at the national and regional levels in the six ACP regions;
- Continuously extend the network of research experts and institutions to cover a larger spectrum of countries within the ACP regions;
- Create an ACP Observatory on Migration website, including an online database for migration experts from the ACP countries, and a second database on intra-regional movements and the nature of migration both within the region and in each of the concerned countries;
- Develop a common methodology for data collection, processing and analysis to systematize and harmonize data and information on migration;
- Monitor, implement and support pilot research projects to test out new methodologies to assess the impact of migration and migration policies on development;
- Develop training tools to be applied in workshops and seminars for academics and experts to enhance their capacity to collect systematized data and with regard to a research methodology on migration-related issues;
- Organise national consultations for policy-makers, civil society and researchers to provide a tool for exchange of migration information and knowledge;
- Establish a system for reporting on key migration policy developments in the ACP countries;
- Convene migration conferences at national, regional and ACP levels with all relevant stakeholders, including regional organizations.

The African, Caribbean and Pacific Group of States includes 79 countries. Project activities will start in 12 pilot countries while progressively expanding to other members. The Research Consortium can also be joined by Universities, research centers, government agencies, private consultants and general public from around the world.

Key Outputs

- Existing migration research networks and newly created national migration observatory centres are linked under the umbrella of the ACP Migration Observatory, in close cooperation with other migration research centres;
- Data on migration is gathered and analyzed in accordance with the generic methodology developed and made available on the ACP Observatory on Migration website;
- Migration specialists are trained to facilitate the collection of harmonized data as well as policy-makers, civil society and researchers to foster their capacity to develop and assess migration policies;
- ACP Reports on Migration and Migration Policies as well as policy-oriented studies on different aspects of the interrelationships between migration and development are published;
- A consultation mechanism for decision-makers, civil society and researchers focusing on sharing of information and findings concerning migration is installed;
- An ACP Migration Observatory is established within an ACP country, coordinating research activities on migration, providing support to future research and disseminating data and research results to ACP interested parties.
